



# (III) BOARD OF TRUSTEES :-

The administration, management and control of the Trust and its properties shall vest in the hands of the committee to be called the Board of Trustees, consisting of all the above mentioned trustees.

- i) The Trustees shall hold office during their life unless any of them desires to be discharged of his duties or becomes mentally or physically incapable of working or is declared insolvent or is convicted of a criminal offence.
- ii) In the event of a vacancy arising in the Board of Trustees for whatever reasons, the remaining trustees shall co-opt another major male or female person out of the family members of that persons to fill up the vacancy.
- iii) The trustees shall work in an honorary capacity, but they shall be entitled to re-imburse expenses incurred by them in the conduct of their duties or in promotion of the objects of the trust or on behalf of the trust.

# (iv) POWERS OF THE BOARD OF TRUSTEES :-

The Board of Trustees shall have the following powers:-

- To invest funds and collect interest thereon.
- ii. To receive and collect donations, gifts in cash or kind.
- iii. To borrow money, raise loans from any person, bank or financial institutions in such manner as the trustees shall think proper or convenient for the furtherance of the objects of the trust and for this purpose the trustees may secure repayment of these loans in any manner as may be decided from time to time.

- iv. To open the accounts in any Nationalized, Scheduled, Cooperatives or Rural Banks in the name of the trust which shall be operated jointly by any two trustees as authorized by the Board of Trustees.
- v. To frame rules and regulations for efficient management of the Trust.
- vi. To add, amend, alter, vary and modify the rules and regulations framed by it.
- vii. To purchase, sell construct, lease, transfer, otherwise, both moveable and immovable properties. The board of trustees shall be the custodian of all movable & immovable properties of the trust.
  - viii. To appoint auditors.
- ix. To form committee or committees to achieve the objectives of the Trust. Such, a committee may consist either some of the trustees or of some of the trustees together with any other person or persons whom the trustees may select provided that the trustees may at any time revoke either wholly or partly the authority so conferred on any such committee.
- x. To appoint personnel to organize and promote the objects of the Trust and to regulate their conditions of services, including matter of discipline, etc.,
- xi. The Trustees may authorize any of the Trustees to appear before the Registrar or Sub-Registrar or any other officials appointed for registration of deeds, documents and other instruments and to execute, present, admit and register or cause to be registered any deed, documents, etc., in which the Trust is interested or involved.

xii. Within the limits prescribed by this instrument, the Trustees shall have power to do all acts, deeds and things necessary or expedient for the carrying out of the objects of the Trust.

xiii. The Board of Trustees shall have power to let or demise the immovable property forming part of the Trust. Property or any part thereof for such period (even for perpetuity) and no such terms and conditions as the trustees may in their absolute discretion think or sell or dispose off any of them or any part thereof or impose any restriction on the property thereof and to purchase immovable property out of the trust property or the sale proceeds of the necessary sold or from the corpus of the Trust Fund or Revenue Fund or use the existing building, and to vary and transpose the investments for the time being provided that the investment shall be such as are hereby authorized.

xiv. The Board To Trustees shall have full power to settle out or compound all suits actions and other proceedings and all differences and demands and to refer any or all of such differences of demands to Arbitration and to adjust, settle and approve all accounts relating to the Trust funds and to execute release and to do all other acts and things relating here to as if they were absolutely entitled to the Trust property and without being answerable for the loss occasioned thereby.

xv. The Board of Trustees shall see to the preservation and proper investment of the trust property which comes to their hands from time to time and to hold the same and to dispose of the same in accordance with the objects of the Trust.

xvi. The Board of Trustees shall be at liberty to take on hire or rent by property for the Trust to carry out its objects.



#### (V) MEETINGS :-



- A notice of at least 15 days time shall be given to Trustees for the Annual general meeting of Trustees with agenda for the meeting.
- The Quorum for a meeting shall be 2/3rd of the total Trustees.
- 4. If a meeting of the General Body is adjourned for want of quorum, the adjourned meeting shall only transact the business specified on the agenda for the earlier meeting. No quorum shall be required for such a meeting, which is adjourned for want of quorum, previously.
- 5. An 'extra-ordinary' general meeting can be convened with minimum 3 days notice to consider only urgent matter which shall be listed on the agenda and no other subject shall be considered and discussed therein.

# (vi) FUNDS & BANKERS :-

- a) The funds of the Trust shall be invested in the modes specified under the provisions of section.13(1) (a) read with section.11(5) of the income Tax Act-1961 as amended from time to time.
- b) Bank accounts shall be opened in the name of the Trust with any nationalized/scheduled/co-operative Bank (s) which shall be operated by joint signature of two trustees as authorized by the Board of Trustees.

# (vii) ACCOUNTS & AUDIT :-


a) The trustees shall cause true and complete accounts of the transactions of the trust to be kept and shall cause such accounts to be balanced as on 31st day of March every year.

# (III) BOARDOF TRUSTEES :-

The administration, management and control of the Trust and its properties shall vest in the hands of the committee to be called the Board of Trustees, consisting of all the above mentioned trustees.







- 4. If a meeting of the General Body is adjourned for want of quorum, the adjourned meeting shall only transact the business specified on the agenda for the earlier meeting. No quorum shall be required for such a meeting, which is adjourned for want of quorum, previously.
- An extra-ordinary general meeting can be convened with minimum 03 days notice to consider only urgent matter which shall be listed on the agenda and no other subject shall be considered and discussed therein.

# (vi) FUNDS & BANKERS:-

- a) Funds of the Trust shall be invested in the modes specified under the provisions of section 13 (1) (a) read with section 11(5) of the income Tax Act-1961 as amended from time to time.
- b) Bank accounts shall be opened in the name of the Trust with any nationalized/schedule/co-operative Bank (s) which shall be operated by joint signature of two trustees as authorized by the Board of Trustees.

# (VII) ACCOUNTS & AUDIT:-

a) The trustees shall cause true and complete accounts of the transactions of the trust to be kept and shall cause such accounts to be balanced as on 31<sup>st</sup> day of March every year.

b) A Balance sheet shall be prepared as on the 31<sup>st</sup> day of March every year as well as a revenue and expenditure accounts for the twelve months ending with 31<sup>st</sup> March.

c) The accounts of the trust shall be audited by Chartered Accountants appoints for the purpose who shall make report thereon to the members.

d) The annual revenue and expenditure account and the balance sheet with the auditor's report appended thereto shall be signed by the Board to Trustees along with the auditors and shall be placed before the members for adoption at their next annual general meeting.



 e) Auditors of the Trust shall be appointed by the general body in the annual general meeting and their remuneration would be fixed in every AGM.

f) The auditor so appointed shall not be a Trustee on the Board of Trustees. The Auditors so appointed shall be a Chartered Accounts

within the meaning of Chartered Account Act.

g) The term of the auditor shall be till the conclusion of the next annual general body meeting of the trust. The retiring auditors shall be eligible for re-appointment.

### (VIII) WINDING UP

In the event of dissolution or winding up the trust, the assets remaining as on the date of dissolution shall under no circumstances be distributed among the trustee/Board of Trustee/Government Body, but the same shall be transferred to another charitable trust whose objects are similar to those of this Trust and which enjoys recognition under section 80G of the income Tax act-1961 as amended from time to time.

### IX) MISCELLANEOUS:-


